Minutes of Inaugural Meeting

1. Welcome and introductions

The Chair welcomed attendees and invited them to introduce themselves.

The Chair explained that the purpose of the meeting was to re-establish the APPG on Schools, Learning, and Assessment.

2. Overview of previous work of the APPG

Chris Brown explained that the APPG was established in 2022 to promote and support school level education and the quality of learning and assessment for all pupils. During the last parliamentary session, the former Group launched a select committee style inquiry to investigate the case for assessment reform. Following the inquiry the Group published a report: <u>'Towards a fairer, more useful and fit-for-purpose way to assess children and young people in the 21st century'</u>.

Attendees noted that they would be supportive of producing a similar select committee style report.

Previous meetings explored a full breadth of issues across our school system, including on teacher training. A meeting on teacher workload had been planned but this was cancelled after the dissolution of Parliament.

3. Name and Purpose

The Chair sought agreement from the Group on the proposed name and purpose for the APPG. The following was proposed:

- Name: All-Party Parliamentary Group for Schools, Learning and Assessment
- Purpose: to promote and support school level education and the quality of learning and assessment for all pupils

The proposed name was agreed to, but after discussion, the proposed purpose of the APPG was amended. The agreed purpose is to promote and support school level education, the quality of learning, assessment *and outcomes* for all pupils.



4. Election of Officers and Confirmation of Membership

5. Election of Secretariat

The National Education Union (NEU) was elected as the secretariat for the Group after all attendees voted in favour. The NEU is responsible for arranging meetings and formally administering any business. The NEU will work closely with, and has already engaged with, other organisations and APPGs in this area to ensure that the Group is collaborative and effective in its outputs. The NEU has budgeted for the provision of secretariat services for the APPG for the year ahead.

6. Future programme of work



The Chair gave an overview of some possible meeting topics for the year ahead:

Accountability and Report Cards

- This session would look at the Government's proposals to reform Ofsted inspections to a 'report card' system rather than single-word grading.
- Members could consider how report cards could best reflect different aspects of school performance and make recommendations to the government.

Curriculum and Assessment (with a focus on subject choice)

- This session would consider the number of hours that different subjects across the curriculum get studied by pupils and why humanities and arts take-up has declined considerably over the last two decades.
- This would link to the Curriculum and Assessment review and Becky Francis has indicated that she would be happy to attend an APPG meeting on this as a guest speaker (preferably in late February).

Global Teacher Recruitment and Retention

- This session would consider the impact of the UK government and multi-academy trusts increasingly recruiting overseas-trained teachers address the ongoing teacher recruitment and retention crisis.
- Members could develop recommendations for the UK government to better support ethical overseas-trained teacher recruitment practices and equitable pay.

Children's Wellbeing Bill

• The Bill is expected to be published soon. It will have wide ranging implications for the education sector. The APPG may wish to hold a briefing for parliamentarians on the Bill to help inform legislative scrutiny and understanding of the proposals.

Other topics suggested by members who attended the meeting included:

- Workload (Chris Vince MP)
- Meeting with exam boards to discuss curriculum and assessment (Lord Hampton)
- Home school education (Lord Watson)
- Social and emotional learning (Sam Rushworth MP)
- Sports in schools (Andy McNae MP)

It was agreed that the next meeting of the APPG in January would focus on workload and recruitment and retention.
